SHIRE PRESIDENT'S REPORT - MARCH 2023

On Monday 16 January, the Council welcomed Mr Rob Stewart onboard as the Acting Chief Executive Officer following on from Mr Pascoe Durtanovich. Mr Stewart had been introduced to the community at the Shire Christmas Party in December 2022.

I attended a General Meeting of the Midwest Yilgarn Infrastructure Group via telephone last 7 February when the guest speaker was Steve Lewis, CEO of Southern Parts. There is now the possibility of some capacity for iron ore producers in the Midwest and Yilgarn Iron Ore Regions to export their produce through the Esperance Port. Juno Minerals is progressing the Yunndaga Rail Siding Site with consideration of becoming a multi-user facility. Also from the meeting, it was noted that the State should be working towards a Magnetite Strategy because of the reserves of the ore situated in the Midwest and Yilgarn Regions.

The General Meeting of Electors was held in the Menzies Town Hall on 14 February. A good attendance by electors, staff and available Councillors ensured resolutions, healthy debates and matters voted on. It is pleasing to see an increase in electors attending the General Meeting from the days of just the CEO and the President receiving the Annual Report and no general business.

A funeral took place on Wednesday 22 February 2023 at the Kookynie Cemetery for Les (Lazy) Baulch, a long-term resident of Tampa/ North Kookynie. A very protracted process took place before permission was granted by the Minister and the Governor for the burial to happen in a closed cemetery.

- The expenditure of up to \$20,000.00 for the installation of an automatic sliding gate and associated componentry for the Menzies Caravan Park has been authorised by the Council.

The Council has also noted the following decisions made during the General Meeting of Electors held 14 February 2023:

- The intention of the Acting CEO to hold Community Catch Up meetings on a monthly basis so that ratepayers and residents can raise matters with the Acting CEO;
- The intention of the Acting CEO to investigate

the dissemination of Menzies Matters and to make improvements as necessary;

- The intention of the Acting CEO to report to the Council in March 2023 relating to a review of the contractual arrangements in place for Donna's Diner in Shenton Street Menzies;
- The provisions of Section 5.9 (2) (c),(d), (e) and (f) of the Local Government Act 1995 as those subsections relate to future appointments to committees of the Council;
- The intention of the Acting CEO to investigate an increase in the number of surveys undertaken by the Council to better gauge public opinion;
- The intention of the CEO to investigate the causes of high staff turnover and, if considered necessary, develop staff retention strategies.

Labour Day is an annual holiday to celebrate the achievements of workers. Labour Day has its origins in the labour union movement, specifically the eight-hour day movement, which advocated eight hours for work, eight hours for recreation, and eight hours for rest.

For most countries, Labour Day is synonymous with, or linked with, International Workers' Day, which occurs on 1 May. For other countries, Labour Day is celebrated on a different date, often one with special significance for the labour movement in that country. Labour Day is a public holiday in many countries. Labour Day in Australia is a public holiday on dates which vary between states and territories. In some states the dates commemorates the Eight Hours Day march. The first march for an eight-hour day by the labour movement occurred in Melbourne on 21 April 1856.

On this day stonemasons and building workers on building sites around Melbourne stopped work and marched from the University of Melbourne to Parliament House to achieve an eight-hour day. Their direct-action protest was a success, and they are noted as being among the first organised workers in the world to achieve an 8-hour day, with no loss of pay.

It is the first Monday in October in the Australian Capital Territory, New South Wales and South Australia. In Victoria and Tasmania, it is the second Monday in March (though the latter calls it Eight Hours Day). In Western Australia, Labour Day is the first Monday in March. In Queensland and the Northern Territory, Labour Day occurs on the first Monday in May (though the latter calls it May Day). It is on the fourth Monday of March in the territory of Christmas Island.




From the Yilpa Classroom:




From the Marlu Classroom:



With Commissioner for Consumer Protection Trish Blake Record-breaking scam losses and victims in WA

WA Scamblet has released a 2022 scam report, with 1,203 people reporting combined losses of \$15,988,513 - a seven per cent increase on 2021's recorded losses and recorded amount of victims.

The report reveals online shopping and classified scams claimed the most victims.

274 online shoppers lost a total of \$876,774, with 270 buyers and sellers on classified sites losing a total of \$564,680 - likely due to COVID-19 reaching its peak in WA and the need to isolate at home.

The top two scams reported to the Consumer Protection Contact Centre were the Amazon phishing scam - an SMS, email or phone call about an undelivered package or item supposedly being held at a distribution centre, and the cryptocurrency investment scam.

Scams relating to the myGox phishing scam increased by 2,650 per cent from two enquiries in 2021 to 55 in 2022. In most cases, the scammers attempted to gain access to consumers' banking details by claiming the consumers were entitled to a refund.

Investment scams, mainly involving crypto currencies, were to blame for \$6,980,254 in losses, while \$2,871,468 was lost to dating/romance scams - with one individual losing \$800,000.

The disturbing 'Hi Mum/Dad' text scam tricked 59 victims into paying \$265,353 with criminals posing as desperate children needing urgent financial assistance from their parents.

The Australian Competition and Consumer Commission has reported that annual scam losses nationally are at least \$2 billion and could be as high as \$4 billion. Alarmingly, a survey has indicated that only about 13 per cent of scam losses are reported to authorities, indicating that these figures are only the tip of the iceberg.

Scammers are getting smarter and scams are getting harder to spot so consumers need to be even more vigilant with all communication online and over the phone.

With every phone call, text message or email it's important practice the pause... and think, could this be a scam? If it is too good to be true, it probably is. Keep your personal information safe and only give it out once you have verified the legitimacy of the request through your own research.

Don't fret over a new pet - know your rights

Buying a pet is a decision many people make with their hearts as well as their heads, meaning it can be a particularly devastating experience when things go wrong with a new companion.

The issues we hear about can vary – from new pets with significant health issues or not matching their description (such as size or pedigree), to breeders taking upfront deposits for litters that are never born

That's why we have launched a new campaign to help empower new pet owners to understand how the Australian Consumer Law protects them in the same way as it does for other purchases.

Buying from a shop or breeder (that is a business) entitles you to receive an animal that matches its description, be of acceptable quality, free from significant health issues and have a healthy lifespan relative to the breed or species. Any additional promises made about the pedigree, condition, performance or other characteristics must also be upheld by the trader.

This means if you encounter a genuine pet purchase issue, you may be entitled to receive a remedy (such as financial compensation or reimbursement of out-of-pocket expenses) while still being able to keep the animal.

These protections are unlikely to apply to private sales when someone sells a pet on a one-off or ad hoc basis, so extra caution is advised if buying this way.

Ask if you can visit where the pet was born and meet its parents to check it has been well cared for, see how big it is likely to grow and what its temperament may be like.

Avoid pet scams – or inadvertently supporting a puppy farm or poor breeding practices – by not buying online if you can't meet the animal first.

If buying a pet isn't for you, consider adopting a new companion from an animal shelter or rescue.

Seafood lovers urged to have their say

With a world-class fishing industry right on our doorstep, it's little wonder so many Western Australian consumers are hooked on seafood.

But if you've ever sat down at a restaurant and thought there was something fishy about the menu, rest assured that changes are coming to help clear up some of the confusion.

In a move designed to increase consumer awareness about where our food comes from, the Federal Government is working with restaurants, cafés and hotels across Australia to | implement mandatory country of origin labelling on the seafood being served.

Knowing where their food comes from can be important for consumers, who may be prepared to pay a little extra for home-grown products. However, research found a common misconception exists that seafood sold in hospitality settings is Australian, when it is actually often imported.

Under the new plan, businesses will need to show if their seafood is from Australia, imported or both, and the Federal Government's Department of Industry, Science and Resources is inviting feedback on how it will work.

Some restaurants and cafes already display seafood origin information for consumers, however there isn't any national consistency like there is for food purchased at the supermarket.

Since 1 July 2018, a mandatory country of origin food labelling system has been in place for food available for retail sale in Australia, including food sold in stores or markets, online or from a vending machine.

Any labelling claim likely to mislead consumers is a breach of the Australian Consumer Law. If you see a country of origin claim that you think is misleading or does not comply with the law, then you can make a consumer complaint.

How to avoid hiring a shady tradie

Whether you need a qualified tradesperson to tackle a home project or a handyman for a quick repair, it's important to know the operator you've hired is trustworthy and reliable.

While the majority of tradies do the right thing, we are contacted by disgruntled consumers about the minority that don't.

In the past 12 months, we have received 579 complaints about those working in trades industries, mostly to do with them failing to exercise due care and skill, as well as wrongly accepting payment.

One trader we strongly urge consumers to avoid doing business with is Kyle John Graham <u>Feisst</u> (also known as Chris Johnson or John Miller), a Perth air-conditioning installer and builder of custom vehicle trailers.

Mr Feisst, who advertises under numerous business names on Facebook Marketplace – including Perth Refrigeration & Air Conditioning Repairs; Wat4Now Customs (also spelt Wot4Now Customs); Perth Air Services; and Aim Mechanical – has so far refused to resolve the 42 outstanding complaints we have received from consumers claiming to be owed \$62,000 for incomplete or no work.

To avoid being left in the lurch if a tradie fails to deliver or goes broke, we always recommend only paying a minimal deposit of about 10 per cent or, for larger jobs, negotiate progress payments as stages of the work are completed.


Paying by credit card is a good option as it provides the protection of getting a chargeback if the goods or services aren't delivered.

Pricing and overcharging are other common issues reported to us, so always get several quotes to compare prices and avoid any surprises once the job is complete. Ensure tradies are licensed (if required) or accredited by trusted industry bodies and search online for positive or negative reviews. Verify claims by asking to see previous work and speaking to past clients.

Ask to see a certificate of currency for public liability insurance, which will protect you or third parties against any damage the tradesperson may cause.
