





PRESIDENT'S REPORT SEPTEMBER 2023

Cr Ian Baird and I attended the 2023 National Local Roads, Transport, and Infrastructure Congress on 6 and 7 September.

On Wednesday 6 September, Senator the Honourable Carol Brown, Assistant Minister for Infrastructure and Transport, delivered an address. Also present were Cr Patrick Hill, President, the CEO and Councillors of the Shire of Laverton who were at Parliament House attempting to arrange a meeting with her or the department regarding Aboriginal Business Roads within the Shire of Menzies, Laverton, and Ngaanyatjarraku. Unfortunately, the meeting could not be arranged, but a video conference may take place.

Day 1 of the Congress featured two keynote addresses. The Grattan Institute Transport and Cities Program presented 'Data is the Key', which contains relevant information for our regions, in this case the Shire of Menzies, concerning traffic monitoring, Automatic Traffic Counters/Classifiers, and shared resources for the road network. Simon Baxter, Manager of Heavy Vehicle Access at the Department of State Growth Tasmania, introduced the online accessible system HVAMS, which automates the road and structure assessment function of heavy vehicle assess decisions under the Heavy Vehicle National Law, currently applicable to Tasmania and being assessed in some other states at present.

A Congress Dinner was held at the National Arboretum, Molonglo Valley, a building fitting of our National Capital.

On Day 2, (Thursday) there were two keynote addresses. The first, presented by Charlie Emery, Managing Director of Soilco, discussed 'Developments in Waste and Recycling'. An interesting presentation regarding waste, which is also being seen on TV and other media forums as we transition to recycling and sustainability. In between the Keynote Addresses, there was a very interesting session on Telecommunications Infrastructure, with speakers including Warren Sharpe OAM, Warren Sharpe Strategic Services Pty Ltd, who spoke about his role at Eurobodalla Shire as the Local Emergency Management Officer and other roles for 38 years there, during the devastating 2019/20 bushfires and numerous flood and storm disasters over more than 20 years including COVID 19 pandemic. Riveting to say the least. Christine Cawkell, Regional Engagement Manager at Telstra, discussed telecommunications during disasters and current availabilities like low orbit satellites for mobile phones in two years. Telstra and Starlink have an agreement to provide voice only and voice plus broadband in rural Australia, pricing and device details expected late 2023. Jennifer Medway, Manager of the Regional Tech Hub, talked about the hub's services, offering independent, free advice regarding telecommunication services for regional, rural and remote Australians. With the cessation of 3G in 2024 the service may be a good choice for those of us who live in the Menzies Shire and beyond.

The second Keynote address was given by Dr Ian Faulks, partner Safety and Policy Analysis International. I have heard Dr Faulks presenting before in like-minded forums, twice before over the last decade and find his statistics interesting regarding traffic safety and offender management, road policing and human factor aspects, new automotive and digital technologies, of particular interest, as a generated input from the Assembly delegates reflected. I have included information of a slide from the presentation.

'Unsafe Seven' factors involved in traffic offences and road crashes.

There are seven main reasons why people <u>commit traffic offences</u> and get killed and injured in road crashes:

- ALCOHOL
- 2. Other Drugs (illicit, prescription, over-the-counter)
- Speed
- Not using seat belts/helmet and protective clothing.
- Fatique
- Distraction and inattention
- 7. Illegal manoeuvres

Cr Jill Dwyer and I drove to Perth on Sunday 17 September, arriving in time to attend Welcome Drinks and the Awards of the Western Australian Local Government Association (WALGA) Convention at Crown Towers, Burswood.

Monday began with the official opening and speeches from the Premier, WALGA President and after lunch the WALGA AGM. Throughout the day, delegates could visit the Convention Exhibition for morning/afternoon tea, lunch and speak with suppliers at the booths.

On Tuesday 19 September, along with WALGA President Karen Chapple, we signed the Climate Change Declaration Certificate for the Shire of Menzies. The Convention Supplier Showcase, opened in Carpark P8, where delegates could browse equipment and plant. This was a welcome addition, which has been missing from the Convention in recent years.

The Convention concluded at 3pm, reflecting a shorter but sharper event.

The WA Midwest Yilgarn Iron Ore Infrastructure Group Inc. held a General Meeting via video conference on Thursday 21 September. This was something of a low-keyed event following on from the AUSIMM Iron Ore Conference on 18-20 September 2023. An Esperance Port update from Scott Bates started General Business. The Guest Speaker was David Trotter, Mineral Research Institute of WA, who spoke on Project characterisation, decarb of magnetite, the AUSIMM Conference summary and some discussion on the Leonora Esperance Rail.


The following items were considered by the Council at its Ordinary Meeting held on 28 September 2023:

- Approved the Christmas shutdown over the Christmas period. During this time, the Shire Administration Office, Community Resources Centre (CRC) and Works Depot will be closed from 4.30pm on Thursday 21 December 2023 and will reopen on Tuesday 2 January 2024 at 8.30am. Additionally, the CRC will remain operational with limited hours from 9.00am to 2.00pm on days other than public holidays or weekends.
- Approved that expressions of interest be sought from incorporated not-forprofit organisations for the leasing from the Council of Lot 8 Shenton Street for community purposes which would incorporate the existing structure on that lot.
- Accepted the invitation from the Western Australian Local Government Association (WALGA) that the Shire of Menzies register as RoadWise Council.
- Appointed a lessee to run the diner at 53 Shenton Street, Menzies.

Election Information



Voting in Local Government Elections

Local Government Elections this year will be held on 21 October and are 'in person' elections. Many Councils also run 'postal vote' elections.

Local Government elections are different this year in that they will be 'optional preferential' rather than 'first past the post'.

First past the post simply means that the candidates with the most number of votes, win. Although this is straightforward, when there are multiple candidates, the situation can develop where a majority of voters don't want the candidate who was elected. For example, if there a ten candidates for one position, that candidate may be elected with only 11 percent of the vote while 8 candidates received 10 percent of the vote and one other receiving 9 percent.

The introduction of preferential voting is the same as that used at state and federal elections, with a major exception. At state and federal elections you must number all the boxes in order of your preference. At this year's local elections, you will not be required to number all the boxes. However, once your numbers run out, your vote is 'exhausted' and no longer counted.

Although a preferential count can be complex, it is worth knowing how your vote is counted. For example, if no candidate has reached a majority of votes after first preferences are counted, the candidate with the least number of votes is excluded and their votes are distributed according to the preferences of voters. This will continue until the quota of votes is received.

For multiple vacancies, the process is the same, but when one candidate is declared elected, their preferences are distributed to fill the other vacancies. Preferences are distributed though at a reduced value.

Voting in Local Government Elections (cont.)

In a local government election, even though you only have to fill out the number '1' for your vote to be counted, unless you fill out more numbers, your vote is exhausted after first preferences are counted. It's worthwhile thinking, while you're in the voting booth, who you may like to be elected if your first preference doesn't get elected. You may also like to think, for a multiple vacancy election, if your first preference gets in, who would you like to also get elected.

Local Government Reform

Voting in the October 2023 Local Government Elections

The State Government is putting into action the most significant reforms to the local government sector in 25 years. The reforms will increase the transparency, accountability and efficiency of local government in WA.

One of the key reforms is the change from "first past the post" system of voting to optional preferential voting (OPV).

This change will be introduced for the October 2023 local government elections which will now be in line with state and federal elections.

OPV will strengthen democracy by giving ratepayers a greater choice of candidates.

Local Government Reform and the

October 2023 Local Government Elections

Dear Resident,

As the new Local Government Minister, I am honoured to oversee the implementation of the Government's major reforms of the local government sector, the most significant in 25 years. At the heart of these reforms is our aim of increasing the transparency, accountability and efficiency of local government in WA.

Some changes will be introduced at the upcoming October local government elections which will give ratepayers a greater say on who they elect to represent them on council. All electors will need to be aware of these changes when casting their vote.

One important change is the switch to Optional Preferential Voting (OPV). This will bring local government elections in line with state and federal government elections. Under OPV you will be able to choose one or more candidates by numbering them in order of your preference.

For many smaller councils, reforms will also see changes to council representation, with the removal of wards and standardisation of the number of councilors aligned to the population of the districts they serve.

These changes will strengthen local democracy and give ratepayers a greater choice of candidates. As a result, the reforms will increase community confidence in local government and make councils more representative and responsive to ratepayers' needs.

For 12 years, I served as a councillor and later as Deputy Mayor at the City of Stirling so I have first-hand experience and an appreciation of the importance of local government and how it impacts the lives of residents in many ways. So it is vital that people get involved in their local government, either by nominating to be a community representative or by voting to have a say on who represents you on council.

What a big term we have just had. New enrolments, a school camp, faction carnival, interschool carnival, getting on the radio, going to the Oasis and starting daily reviews.



School trip to Queensland:



dren or the trip. All parents had been very supportive since the first meeting and were excited for their children about this trip.







bane City. At night, we went to Australian Outback Spectacular to watch a show and enjoy a lovely meal.













Mollie-Findlater-Smith was born in 1906 at Boulder, Western Australia, the youngest child to parents John Cruickshank Smith and Mary Jane Smith nee Morgan.

Mollie often called girlie, was a popular member of the Goldfields community which was proved with the hundreds and hundreds of mourners who attended her funeral and sent messages of condolences to her family.

These condolences included her many family and friends from the Boulder Central School, the girl guides, the Eastern Goldfields High School, the Teachers Union and of course the many people from Menzies including her work colleagues at the Menzies school.

The list in the newspaper was certainly a tribute to the great affection for which everyone had for Mollie, especially her close friends Beryl and Flora who continued to place memorial notices in the newspaper for Mollie nine years after her death.

Mollie seemed to be a great scholar picking up many prizes for art, music and her academic abilities. She passed her leaving certificate in 1922 and achieved her position in Menzies in 1923 as assistant teacher.

Mollie's tragic accident occurred on Tuesday 2nd July, 1924 and the following story is taken from the Western Argus newspaper following her death.

Mollie was giving a lesson to the infant class and was standing in front of a fire in an open fireplace when by some means her clothing became ignited and almost instantly was in flames.

A young student named Cyril Templeman rushed to Mr Williams the headmaster, whose room was the end of the building and gave the alarm.

When Mr Williams reached the class room he could not find Mollie, but found her near the wall in the adjoining room. She was enveloped in flames. He immediately grasped some flags and wrapped them around her, extinguishing the flames.

He immediately sent for Dr Clark and Matron Motley, who were speedily in attendance and rendered instant assistance. Miss Smith was removed to the hospital when on examination the serious nature of her injuries was seen and despite all that medical skill and careful nursing could do she passed away on Thursday morning.

An enquiry was opened on Thursday afternoon at the court house before Mr C.N. Spargo, acting coroner.

Cyril Templeman a student of nine years of age, stated that Miss Smith was standing in front of the fire, reading the lesson to the children, when they noticed that her dress was on fire and called out to her. She commenced to try to beat it out with her hands and he ran to the head teacher and gave the alarm.

Mr Williams, the headmaster, stated that when he ran into Miss Smith's room he could not see her there, but found her standing against the wall in the adjoining room. He immediately grasped some flags and wrapped them around her, eventually getting the fire out.


Dr. Clark stated that on examination he found severe injuries from burns spread over the whole surface of her body. Her condition was very low. On Wednesday she rallied slightly, but towards Thursday morning she collapsed and passed away from acute coma, following acute nephritis, supervening on the shock and destruction of the large area of skin surface. Mollie's family was in attendance when she passed away.

Mollie had been residing in Menzies a few months. She was described as having a kindly and genial manner and had won the esteem of all classes of the community.

On Sunday 3rd July this year, Miss Janet, Peter and myself were invited by the Boulder Historical Society to attend a ceremony at Mollie's grave site at the Boulder cemetery. It was a very moving ceremony and an elderly relation of Mollie's was in attendance.

Her name is Jan Mayman and she hopes to come and visit Menzies. She is a free lance journalist and would like to write a few articles about Menzies.

Community Catch up




As a result of a query at the General Meeting of Electors, the Acting CEO has resurrected the practice of Community Catch Up Meetings once per month.
