THE SHIRE PRESIDENT'S REPORT July 2021

The long weekend holiday started off with the Leonora Inland Art Prize Opening Night on the 4th June 2021. Joining myself was the CEO, Brian Joiner and his wife Eve, Cr Jill Dwyer and the Deputy President Ian Baird, who travelled in from Tjuntjuntjarra for the Ordinary Meeting of Council at 27 May and stayed on to take in the festive weekend and to mix and meet the local communities at Menzies and Leonora. The Inland Art Prize Night was well attended and the Menzies Shire is pleased to be a long term sponsor of the well recognized biennial event in the Goldfields of Western Australia.



Saturday 5th June opened as a cool clear day for the running of the 92nd Menzies Classic, Chas Egan. Memorial Cycle Race, with riders departing Kalgoorlie around 10am. The finish was exciting with fast finishing group lead by Michael Tapscott 1st, Rachel Wales 2nd and Jessic Lawler 3rd.

The evening kicked off with dinner including entertainment by DJ Rev for around 250 people held in the marquee in the Shire car park. Presentations were conducted during the dinner, including attendance by our Federal member Rick Wilson. Once again the dinner was arranged by the EGCC and contracted to the Kookynie Volunteers Association Incorporated. Another magnificent fireworks display for the grand finale to conclude the evening. Buses were arranged for departures to Morapoi and Kalgoorlie.

Breakfast was provided by the Shire and was well attended on Sunday morning with DJ Rev rocking the town awake and amping up the cyclists prior to their departure for the final leg of the race, the Leonora Golden Wheels.

After presentations to the overall winners of the Cyclassic on the stage in the Tower Street in Leonora, Cr Baird, Cr Dwyer and myself attended a function for the Leonora Golden Wheels awards at the Central Hotel prior to farewelling the cyclists and visitors who were flying to Perth that evening.

Upon our return to Menzies, at 7pm I conducted a Citizenship Ceremony for Dr Ruth Murdy. Rick Wilson MP read out a message from the Minister Alex Hawke MP and presented Dr Murdy with the Australian Flag and a folder containing her citizenship certificate. Following the ceremony a function was held in the camp kitchen of the caravan park to celebrate this proud occasion with Dr Murdy, Rick Wilson MP, Dr Lesley Arnott and members of the Eastern Goldfields Cycle Club.

I would like to thank Dr Ruth Murdy, Minister Alex Hawke, Minister for Immigration, Citizenship, Migrant Services and Multicultural Affairs and Rick Wilson MP for the opportunity to perform this ceremony in Menzies during the Cyclassic Weekend.

On 17th June I attended an Audit Committee Meeting with RSM for the 2020-21 audit following a budget workshop for the 2021- 22 financial year and briefing session with Cr Dwyer in person and Cr Baird on zoom. 22nd June Cr Dwyer, the CEO and I met with DSS for discussions on job ready funding for the CDC trial sites. The extension of services to Menzies will be delivered by Leonora. 23rd June I travelled to Tjuntjuntjarra with Cr Mader, Cr Dwyer and the CEO for the OCM on 24th June. A noticeable improvement on the road from the Trans Access Road to the Kanandah top fence in alignment with the increase in mineral exploration. The previous works in the Shire of Menzies on the Connie Sue and Community roads have settled down well. Further maintenance improvements are required and will be ongoing focus.

CHIEF EXECUTIVE OFFICER'S REPORT

July 2021

The month of June is always very busy for Local Governments with the planning and setting of budgets for the next financial year. This month also included our independent interim audit for the 2020/21 FY which is an enormous drain on Council staff as they answer queries and produce documentation for the audit team. We also received our final audit for the 2019/20 FY and produced the Annual Report which was presented at the Annual Electors Meeting held on the 29th June. Receival of this audit was delayed, along with many other Councils, due to restrictions on travel last year.

On a positive note, was the running of the 2021 Cyclassic event and awards dinner. It was my first time at the event, and I thought it provided the community with a sense of normality after it was cancelled in 2020. The finish of the event was very exciting, and it was fantastic to see two female riders in the top three. The presentation dinner for the riders attracted a crowd of approximately 250 with catering courtesy of the Kookynie Volunteers. We are already looking ahead to next years event and developing ideas to ensure that the Menzies community feels part of the event and to attract bigger crowds.

This months Council meeting was held at Tjuntjuntjara and it was my first visit to the community. We travelled by road and the conditions were very trying on portions of the roads. Council has contractors commencing work on our portions of the roads in July. The countryside in that part of our Shire is amazing and I would like to thank the community for being so welcoming.

A couple of projects were completed this month. The resheeting of Menzies NW and Evanston Roads finished our 2020/21 road program. We also provided seating and shade structures at Lake Ballard, Niagara Dam and the Menzies truck stop. We have an extensive works program for the 2021/22 FY and I'm hoping to have a lot of those projects completed within the next six months.

I was asked to be on the selection panel for a new permanent Principal for the Menzies Community School. Congratulations Megan Irving on your appointment.

My final note for this month is to wish our MM editor, Sethen, a happy 21st for later in July.







Background

NTS Goldfields Ltd (**NTSG**) is arranging this meeting to provide an opportunity to discuss and make a decision about amending the Nyalpa Pirniku Native Title Claim (WAD 91/2019) by adding "(siblings) Sarah Brown and Jack Merrick (children of Bindinni)" as an apical ancestor. This meeting follows a series of consultation meetings with members of the Nyalpa Pirniku claim group.

This meeting is an authorisation meeting. An authorisation meeting is required when a new claim is being considered, or when there is an amendment proposed to an existing claim. The Nyalpa Pirniku native title claim was authorised on 23 January 2019 at an authorisation meeting and was registered on 15 May 2019. A decision to amend the claim at this meeting will authorise a change to the existing claim. The addition of Sarah Brown and Jack Merrick as an apical ancestor would be an amendment to the claim, because it would change the people who are in the claim group.

Anthropological information and legal advice about Sarah Brown and Jack Merrick's connection and the progress of the Nyalpa Pirniku claim will be provided at the meeting. There will be an opportunity to ask questions and have family group discussions during the meeting. The Nyalpa Pirniku claim group will make a decision about whether it wants to authorise an amendment to the claim group description to include Sarah Brown and Jack Merrick as an apical ancestor for the Nyalpa Pirniku claim.



SEVEN GOLDEN RULES FOR PROSPECTING

Put safety first
Make sure you have enough water, fuel, maps and first aid supplies.
Give serious consideration to taking some form of telecommunications and a global positioning system to fix locations, and a Personal Locator Beacon (PLB) – it may turn out to be your most important safety device.

Obtain a Miner's Right permit when prospecting on vacant Crown land (\$25 from any Mining Registrar's office).

Obtain a 40E permit prior to prospecting within an exploration tenement (if you don't have written permission from the tenement holder).

Get written permission from the tenement holder when prospecting on: a mining lease an exploration licence (if you don't have a 40E permit) a prospecting licence

Comply with all legal requirements when prospecting on a pastoral lease. You cannot prospect within 100 metres of any occupied building or within 400 metres of any livestock watering point without the consent of the pastoralist.

Show respect when on Crown land because it is used by other people or set aside for many purposes.

Fill any holes that you dug and repair ground that has been disturbed.

The poison baits remain toxic for many months. You need to exercise caution. Domestic pets should be kept close and under control at all times. Owners may consider the use of leads and muzzles for their domestic pets.

DO NOT RELY ON WARNING SIGNS
