# FINANCIAL INTEREST (EFFECTIVE 1 JULY 1996)

A financial interest occurs where a Councillor, or person with whom the Councillor is closely associated, has direct or indirect financial interest in the matter. That is, the person stands to make a financial gain or loss from the decision, either now or at some time in the future.

An indirect financial interest includes a reference to a financial relationship between that person and another person who requires a Local Government decision in relation to the matter.

## Councillors should declare an interest:

- a) In a written notice given to the CEO before the meeting: or
- b) At the meeting immediately before the matter is discussed

A member who has declared an interest must not:

Preside at the part of the meeting relating to the matter: or Participate in, or be present during any discussion or decision making procedure relating to the matter.

Unless the member is allowed to do so under Section 5.68 or 5.69, Local Government Act 1995

## SUMMARY:

For Council to approve the appointment of an Acting Chief Executive Officer

#### **BACKGROUND:**

Our current Chief Executive Officer, Peter Crawford, tendered his resignation on 15 February 2015 with his final day of work being 31 July 2015. An offer from Council was made to Mr Crawford and was accepted, resulting in Mr Crawford being on paid leave from close of business 8 May 2015 until retirement date 31 July 2015.

The CEO advised the Shire President in person on 15 February 2015 of his resignation and his reasons for providing a long lead time.

## STATUTORY ENVIRONMENT:

Local Government Act 1995

- Section 2.7(2) Provides that Council is to oversee the allocation of local government finances and resources and to determine local government policies; and
- Section 3.1 Provides that the general function of the local government is to provide for the good government of persons in its district.
- Section 5.37(1) Provides for the local government may designate that a person may be classed as a senior employee
- Section 5.39(1) Requires the local government to enter into a contract of employment with a senior employee
- The Local Government Act requires that a Council appoint a person to be the CEO.
- The Act further requires that a person is not to be employed as a CEO unless the Council believes that the person is suitably qualified for the position and is satisfied with the provisions of the proposed employment contract
- The appointment of a CEO (including Acting) requires an absolute majority of Council.
